- A new Section Map is being developed
- Trail would be double blazed in places with the OT marker along with the applicable blaze of the other trails
- There has been an email sent out asking for approval of name


There was a lot of good discussion on the naming with some people suggesting it be named the Upper Current

Meramec River Section Proposal

Mark Goforth, Vice President of the Ozark trail Association presented a proposed 15th section for the Ozark trail. This section would be a water trail gong from Onondaga State Park north on the Meramec river and would be called the Meramec River Section.

- Marked presented the map showing the water trail with designated access point along the river.
- It has been noted that water trails have a higher chance of receiving RTP fund which would be used for installed the necessary thinks like the kiosks and the thought is the OTA would oversee the maintenance of those.
- More discussion will be needed with the agencies.

Norfork Lake Trail






