The secretary announced that the minutes of the 3rd Quarter Board meeting held on August 6, 2022, were provided for the meeting. After discussion, a vote was taken, and the minutes of the meeting were approved by the directors in attendance with one minor correction.

NRT has moved on to the Milwaukee office. We will continue getting additional funding from the GAOA through the end of 2025 when we need it for deferred maintenance projects. We have 2 new hires, Alex and Kaitlin living at the house and they will be leading GAOA projects including AmeriCorps crews in the field or working on other projects when those crews are not in.

Treasurer's Report 3rd Quarter 2022

I have attached several financial reports for your review:

- A Statement of Activity for just third quarter of 2022 compared to the 3rd quarter of 2021. A
 favorable comparison for this year, we had a negative cash flow of \$1,497.36 this year as
 compared to -15,129.21 for the same quarter in 2021. Revenue was higher and expenses less.
 Note that GAOA reimbursements were just starting in the 3rd Quarter of 2021.
- A Statement of Activity for this year through the end of the third quarter. Net Operating Revenue (profit) for the year as of the end of the quarter is \$84,213.90. Net Revenue is \$87,614.71. I would say that this level of profitability is historic. That comes on the heels of a successful 2021 is also noteworthy.
- 3. Statement of Financial Position as of September 30, 2022. This report indicates the positive things that have happened in the first nine months of 2022. However, it does report the effect of nine months of dismal performance of the financial markets have had on our endowment fund. Note also that we established the OTA Reserve fund this last quarter. \$30,000 has been placed in CD's through Edward Jones as follows:

A. The Trail Planning and Development Committee's strategy to guide our efforts

Workstream 1 – Build the on-line trail map and planned trail corridor(s)

- Renew license with ARC GIS Online to support trail corridor planning and trail building efforts
- Download GIS parcel / land ownership data for every county along the current and proposed trail corridors and upload to OTA trail map.
- Upload current trail routes based on GIS data
- Document proposed new trails
- Create online database to document efforts on each parcel for the proposed trail corridor(s)
- Update database with work completed to date

Workstream 2- Engage Community Leaders

- · Create a data base / file to community leaders and engagement activity
- Update with appropriate contact names and contact information
- Develop schedule to reach out and establish appropriate meetings to discuss our vision and plans
- Determine approach for OTC communication and engagement

Workstream 3 – Build foundation for property /trail rights acquisition and protection

- Establish relationships with land trust organizations to partner with the OTA
- Ramp up relationships with private foundations and corporations to support funding of land acquisition / trail rights.
- Determine fit and strategy, next steps for water and road trails
- Develop landowner engagement strategy and documentation

B. Arc GIS Trail Mapping

- a. Completed efforts to renew and expand our ARC GIS licenses. We have 2 creator licenses and 1 viewer license active for a \$250 annual fee.
- b. The goal is to develop a complete picture of the landowners for the existing trail and gap corridors. Once developed we will use this as the foundation for our committee efforts in our work with the landowners along the gap corridors.
- c. Kayla Brinkley has begun our trail mapping efforts. She has downloaded the existing trail map. She has also begun downloading free parcel files from counties that provide this for no cost. Committee chair has submitted a request to spend \$1200 to acquire county parcel maps.

D. Outdoors Alliance / River City Outdoors

Attended the Outdoors Foundation / Thrive Outside/ St Louis River City Outdoors first partner event on Oct 12. My goal for attending this session include:

- 1. Further expansion of network and contacts.
- 2. Potential funding source for trail construction and/or property acquisition
- 3. Contact Great River Greenways representatives to further discuss partnership and strategy. Mark Vogel / Program Manager and plan to meet on Oct 20.

Met with Mark Vogel / Program Manager and Great Rivers Greenway to discuss collaboration with OTA. Following are the highlights:

- We discussed the concept of the OT co-branded on a GRG trail that would extend to the Mississippi
 River. He was not aware of this concept but was not opposed to it. There are several GRG trails that are
 co-branded (e.g., Grant's Trail). We discussed signage standards, updating on-line maps, and promoting
 the trail. As a next step, Mark is going to follow up with GRG leadership to get feedback on this topic.
- The second topic we discussed was the connection between the GRG and the OT at Pacific. Mark explained that GRG has not experienced much support for the Western Area of the GRG. The GRG planning committee is going to be conducting some alternative alignment planning that may result in a reroute away from Pacific. We also discussed how that could impact our route planning efforts as well. Mark did indicate that the GRG places an emphasis on being able to connect with other, larger trail networks. We need to discuss how this impacts our planning efforts and alternatives.

Nature Conservancy	Holly Neill	 Met with Holly Neill, Deputy Director with the Nature Conservancy of Missouri. Holly.Neill@tnc.org Phone 417-827-4864 We discussed the mission of the OTA and our trail building efforts and discussed how we could partner to assist our efforts. Their conservation priorities for Missouri include the Current River watershed. She sent me a map of their owned properties in Missouri that are near our trail and the boundaries of the Current River conservation /watershed priority area. If the OT corridor would be within their Current River conservation focus area, we could potentially partner with the NC to fund trail acquisition rights (easement / purchase). They have a revolving fund whereby they acquire property, attach an easement and resell property (generally at a loss) and maintain the easement.
Ozark Land Trust	Larry Levin Nic Rogers	Met with Larry Levin and Nic Rogers with the Ozark Land Trust (OLT) to discuss our efforts to expand the trail and how they might be able to partner and support our efforts. Their website: https://ozarklandtrust.org/ From our conversation it appears to me that they are willing and eager to support our efforts as long as it aligns with their mission to support property conservation. For example, if we need to acquire a parcel of land to construct a trail, they could possibly support the acquisition of the parcel or secure a conservation easement. Larry suggested that we put together a working group of interested organizations to assist our efforts. This could include organizations such as the Ozark Land Trust, the Conservation Fund and the Nature Conservancy. I think this is a great idea and a topic for our next committee meeting.

Londfor	IT Hore	He also indicated there may be properties / parcels in our future trail corridors that are of interest to the OLT that are of particular interest that they would support. So as we identify trail corridors and parcels we should share this information with them
Land for Public Trust	JT Horn	 Met with JT Horn / Senior Project Manager @ Trust for Public Land Website: https://www.tpl.org/ They love working with trail groups and partnering with trail organizations Land projection work - if we have a section of private land with a willing seller they can help us with securing the land or right of way and conserve it permanently. They have worked closely with the National Forest service and we could work together. Process with NFS can take a long time, but they could work with a willing seller to complete acquisitions. Basically they act as a bridge between the seller and the final owner such as the state forecast or local land trusts They are transaction experts They have the ability to do sophisticated mapping and help determine where trails might go. There expertise is in 2 areas Planning - it is a lot of what they do. Utilizing digital mapping technology they can identify potential routes. They are "word class map-makers" Acquisition - work with the NFS to get in line and support funding. I think this approach will be appropriate to identify potential "forever routes" in the current gaps. They do not have a "pot of money" but have a fee for service arrangement. Could hire them or write and obtain a grant for land acquisition planning and purchase. I indicated that I would discuss these ideas with the executive committee and determine next steps and get back to him.

Report to the Board of Directors 2022 Q4 OTA Construction and Maintenance Report

We have established the entire 2022 Calendar year maintenance and construction schedule. That was done in conjunction with the 5 yr. schedule and high-level C&M 5 yr. plan submitted back in August 2021.

Between Jan – Oct 2022

- there were 31 OT Maintenance events including the Spring Mega, Spring Winona, Fall Mega, Fall Winona events, 8 AmeriCorps events
- o 6 OT-OHT events scheduled (3 canceled due to weather)
- 12 Out Reach Events scheduled (2 canceled due to weather), including Alpine Shop Pint Night in Kirkwood, Backpacker Get Out Event on Taum Sauk, REI Town and Country Grand Opening weekend
- OTA Crew Leader Training in Potosi
- OTA-AmeriCorps Crew Leader Training at CRSP

We have another 7 Scheduled Maintenance Events for the fall between Nov 1- December 17th, which includes 2 OT-OHT Builds, at least 1 AmeriCorps 10-day crew performing GAO tread rehab and 4 events scheduled for which maintenance will be performed as needed,

We still have a very robust list of Ozark Trail enhancement projects using GAOA grant from the USFS. These projects include:

- Karkaghne Project #3 K5a tread re-hab West of Big Nasty on Little Nasty approx.
 1.5 mile **** (this has actually started with the first 750 ft south of Bee-Fork completed 5/22)
- Blair Creek Project #1 BC3 move trail out of drainage areas

- June 2022 was all about clearing the trail down south and up north. Work was done several of normal hot spots on the Courtois, Karkaghne, Trace Creek, Blair Creek, Current River, Between The Rivers and 1 Pt sections in conjunction with AmeriCorps-ERT teams and OTA volunteers.
- We have purchased the following new equipment using donations from OTA supporters and GAOA funding

- We have repaired our older Stihl weed eaters and now have 9 weed eaters available for use and loan out to Adopters and volunteers – equipment has been loaned to

- adopters in Winona, bikers for One Eyed Dog event, and OT100 Endurance Run volunteers
- We have added a lightweight Echo Arborist chainsaw to provide easier sawing for smaller in stature sawyers
- Purchased new OTA Canopy to replaced damaged canopy at Spring 2022 Mega.
- We plan on adding or updating the Kiosks at each trail head as well as improving signage at all trail heads and secondary trail access points. We have purchased wood and supplies to build several new kiosks and signs for placement at various trailheads across the 435 miles of the Ozark Trail system.
